

COMPETITION – Béarn Mountains - From July 5, 2025 to August 31, 2025

Article 1: Competition Organizer

The Ossau Valley Community of Communes, located at 1 Avenue des Pyrénées in Arudy – 64260, is organizing a competition on behalf of the tourist areas of Ossau Valley, Pays de Nay, and Béarn Pyrenees.

This competition will run from July 5, 2025, at 9 a.m., to August 31, 2025, at midnight, included, local time, under the conditions set out by these rules.

Article 2: Participation

This free competition, with no purchase necessary, is open to any individual, adult, resident or visitor. Offer limited to one entry per person and per household (same address, same name) for the duration of the competition.

Participation in the competition constitutes full acceptance of these rules.

Article 3: Competition Announcement

The competition rules will be available on the Ossau Valley Community of Communes website.

Article 4: Prizes

Article 5: Terms of Participation

As such, any registration by telephone, fax, or email will not be accepted.

To participate in this competition, all participants must correctly complete the questionnaire and provide their contact information (telephone and email) before the entry deadline, set out in these rules, which is midnight local time on August 31, 2025.

Any entry that does not complete the questionnaire and/or that uses inaccurate contact information will be considered invalid and excluded from the draw. It also applies if multiple entries are submitted using the same person's phone number and email address. In this case, each entry will be considered invalid. Proven fraud or attempted cheating by a participant, particularly by creating false identities to allow multiple entries, may result in a formal and permanent ban from participating in the draw.

5.2 Winners will be chosen by random draw conducted using Excel from among the correctly completed questionnaires submitted by midnight on August 31, 2025.

5.3 Winners will be chosen by random draw, provided that all mandatory fields on the entry form are complete and valid.

5.4 The draw will be conducted by a representative of the organizer, in public, at the Ossau Valley Community of Communes in Arudy – 1 Avenue des Pyrénées (64260) – on Monday, September 8th at 11:00 a.m.

The prize will be delivered directly to the winner at the headquarters of the Ossau Valley Community of Communes in Arudy – 1 Avenue des Pyrénées (64260) – or sent to the winner at the address they have provided to the Ossau Valley Community of Communes. This prize may under no circumstances be exchanged for its cash value or any other prize.

5.5 The organizer will notify the winners within 7 calendar days of the draw, either by email, if this field has been completed, or by telephone; this information will include the terms and conditions for collecting the prize. The winner's identity will be verified beforehand. If the winner fails to respond within 30 calendar days of the results being sent (text message, email), the prize will be forfeited and the participant will be deemed to have waived the prize.

The Ossau Valley Community of Communes will not be liable to compensate the winner who fails to appear and/or respond within the allotted time.

5.6 Competition winners may use their vouchers until the expiration date indicated on the voucher, with no possibility of changing this date.

Under no circumstances may the winner claim any compensation other than the prize won.

The Ossau Valley Community of Communes will have the final say on any question relating to the application of these rules or any question that may arise not covered by them. These decisions will be final.

Article 10: Data Protection Act
